

Reserves

The Singapore Red Cross maintains a reserve to ensure sustainability of its programmes in the unlikely event that funding or donations fall short of the required programme expenditure. Based on the 2024 audited financial statements, the Society has a reserves ratio (unrestricted funds) of 1.11 years.
