Ms So joined Hong Kong Red Cross Society in 1990, participating in multiple different major services. She was promoted to Secretary General in 2015, and currently leads 1,400 staff members and 22,000 volunteers. She has since been involved in a wide range of disaster relief and reconstruction projects worldwide. Furthermore, Ms So is a member of the Field Assessment and Coordination Team (FACT) of the International Federation of Red Cross & Red Crescent Societies (IFRC), and the founding member of the IFRC Asia Pacific Fundraisers' Network.

Beyond her work at Red Cross, she established the Face-to-Face Monthly Giving Alliance in Hong Kong in 2012 as the founding Chairperson. She is also the current Vice Chairman of the Steering Committee on Work in Mainland China of the Hong Kong Council of Social Service (HKCSS), and a member of its Executive Committee. Additionally, she is a Consultant of the Association Concerning Sexual Violence Against Women, Advisor of the Inspiring HK Sports Foundation, and a Selection Committee member of the Community Involvement Broadcasting Service of Radio Television Hong Kong.

In 2006, Ms So was presented with "The Ten Outstanding Young Persons of Hong Kong" award. She also holds a Master's Degree in New Media, and Strategic Perspectives in Nonprofit Management from Harvard Business School and is currently undergoing the Executive Master's Program in Business Administration.

Dr. Harish L Metha is the current Chairman of Indian Red Cross Society, Tamil Nadu Branch. Singapore Red Cross's first disaster relief mission with the Indian Red Cross was during the severe Chennai floodings in 2015. Our work in India has only increased since, with a mobile clinic and ongoing weekly medical camps reaching out to the poor in Chennai.

For his contributions, Dr Harish received the "Red Cross Gold Medal" from the President of India. In addition, he has an extensive and diverse experience in humanitarian and philanthropic endeavors. Dr Harish is served as the Chairman of *Sri. Sumathi Vishal Dialysis Centre*, President of *Society of Prevention to Cruelty to Animals (SPCA)*, and is the State Commissioner of *Bharat Scouts & Guides*. During his time as State Commissioner, he received the "Silver Elephant Award" – a distinguished scouting award, presented for his commendable and extraordinary service.

Apart from his altruistic efforts, Dr. Harish L Metha is also a veteran in the operations of business organisations. He is the Senior National Vice President of *All India Manufacturers Organisation*, to create an environment for co-operation between Government and Industry. He is also the Vice President of the *National Chamber of Commerce* and a member of *E.S.I. Corporation, Ministry of Labour, Government of India*.

Dr Slim is the Head of Policy at the International Committee of the Red Cross (ICRC) in Geneva. Dr Slim has combined a career in both academia and in practice. Before joining ICRC in 2015, he was Senior Research Fellow at the Institute of Ethics, Law and Armed Conflict (ELAC) at the University of Oxford where he led research on humanitarian ethics and the protection of civilians.

Dr Slim's other experiences in academia include being the Chief Scholar at the Centre for Humanitarian Dialogue from 2003—2007 and Reader in International Humanitarianism at Oxford Brookes University from 1994-2003. Between 1983 and 1994, he also worked for Save the Children and the United Nations in Morocco, Sudan, Ethiopia, the Occupied Palestinian Territories, and Bangladesh.

His most recent books include Humanitarian Ethics: a Guide to the Morality of Aid in War and Disaster (2015 Hurst/OUP) and Killing Civilians: Method, Madness and Morality in War (2007 Hurst/OUP).
